There will be ONE (1) local WYMG Grand Prize Winner at the end of the Pro Football Regular Season, based on their rank. 1st place will receive \$500.00.

There will be ONE (1) local WYMG Weekly Prize Winner at the end of each Pro Football Regular Season Weekly games, based on their rank. 1st place will receive ONE (1) Large 1-Topping Pizza from Papa Johns.
